



Terms and conditions for Hilton Honors

1. To receive a Free Night Reward Certificate, you must complete £750 of eligible purchases within the first 90 days from the date your account was opened. Eligible purchases are net purchases (purchases less returns), excluding any cash withdrawals, balance transfers, cheque purchases, fees, interest, charges or other transactions. Allow up to 6-8 weeks to receive your Free Night Reward Certificate. Your free night e-certificate will be sent to you via email. Please ensure your Hilton Honors account is updated with a valid email address in order to receive certificate.
2. Free Night Reward Certificate will only be awarded for first time applicants of the Hilton Honors Platinum Visa card.
3. Free Night Reward Certificate valid for one complimentary weekend night for a standard room at participating hotels worldwide, subject to availability. This reward is not valid at All-Inclusive or Distinctive properties and cannot be combined with the 5th Night Free benefit or other promotions. If in any calendar year of card membership your total eligible purchases reach £10,000, you will be upgraded to Hilton Honors Gold status for the calendar year in which such status was earned through the end of the next calendar year. Thereafter, standard requirements must be met to maintain Gold status. Allow up to 6-8 weeks for your status to be upgraded. Gold status members may choose from a variety of on-property benefits, which vary by hotel and are subject to availability.
